### Emergency Overview

**Physical Description & Colour:** Yellow liquid.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

**Skin Contact:** Wash gently and thoroughly with warm water (use non-abrasive soap if necessary) for 10-20 minutes or until product is removed. ## Section 6 – Accidental Release Measures
